
STEMMING THE TIDE OF HATE TO BECOME A "BELOVED COMMUNITY"

In various writings and occasions, Martin Luther King, Jr. lifted up the notion of a beloved community, which he envisioned as a society based on justice, equal opportunity, and love of one's fellow human beings.

In the January 14, 2019 edition of *The*Capital City Hues newspaper, editor Jonathan

asked several Madison community leaders reflect on how **all of us** can stem this tide of hate. Following are a few excerpts from their reflections -

Rev. Joseph Baring Jr. Pastor of St. Paul AME Church "Currently there is an atmosphere of hatred permeating the hollowed halls of Congress. Such attitudes stand in opposition to the attitudes cited by Abraham Lincoln in his second inaugural address. In that address Lincoln called for "malice toward none, with charity toward all."

"Let no issue go unnoticed, unstated and unrecognized that has the potential of producing negative life options for residents of the community."
